REQUEST FOR BIDS

The Centre Regional Recreation Authority is soliciting bids for the SPRING CREEK EDUCATION BUILDING project at 614 Puddintown Road, State College, PA. Separate General Construction, Fire Protection, Plumbing, Mechanical and Electrical contracts will be awarded for the work to include construction of the Phase 1 structure and related site development for a new 2,548 square foot two-story wood frame educational building, and related site utilities, parking area and other related site development. The project includes all work to construct the Project complete and ready for use in all respects. PA Prevailing Wage Law applies to the contracts. The project is scheduled to begin construction on or about April 15, 2010, and must be completed on or before February 15, 2011.

A pre-bid conference will be held on Wednesday, March 3, 2010, at 10:00 a.m., at the Centre Region COG Building General Forum Room, 2643 Gateway Drive, State College, PA. Upon conclusion of the administrative portion of the meeting, an overview and walk-through of the site will be conducted.

Sets of Bid Documents may be obtained for a non-returnable cost of \$225 at the office of the Architect on or after February 23, 2010, by calling (814) 466-6675. Addenda will only be issued to those registered with the Architect as having received Bid Documents. In addition, Bidding Documents will be available for review at the office of HPArchitects, 3939 S. Atherton Street, State College, PA 16801, at the Centre Region COG Building, at the Altoona Builders Exchange (814) 944-5444, the Harrisburg Builders Exchange (717) 234-3255, and at the Pittsburgh Builders Exchange (412) 922-4200.

Deadline for receipt of bids is 3:00 PM prevailing time, Wednesday, March 17, 2010, at which time the sealed bids will be publicly opened & read aloud. All bids shall be in a sealed envelope clearly marked " BID FOR SPRING CREEK EDUCATION BUILDING," delivered to Ronald J. Woodhead, Centre Region Parks & Recreation, 2643 Gateway Drive, State College, PA 16801, and be in his possession prior to the date and time stated above.

Each bid must be accompanied by cash, a certified check or a cashier's check in favor of the Centre Regional Recreation Authority, drawn upon a bank authorized to do business in the Commonwealth in the amount of 10% of the bid or by a bond drawn to the order of the same with corporate surety in the amount of 10% of the bid. Certified checks or bid bonds will be returned to unsuccessful bidders. Bidders agree that their bid is valid, may not be withdrawn for a period of 60 calendar days after the bid opening, and that the Authority reserves the right to reject any or all bids, or portions thereof, select individual items from a bid, waive any informalities, irregularities or technicalities in bidding, and to award a contract which, in its judgment, is in the best interest of the Authority. The Authority reserves the right to reject any Contractor or Subcontractor if an investigation fails to satisfy the Authority that such Contractor is properly qualified to carry out the obligation of the contract in a responsible and timely manner.
