A. Nature Center Advisory Committee c/o Ms. Hetrick (ACTION)

B. "Action Sports Park" Proposal c/o Ms. Tourscher

Ms. Tourscher will introduce Mr. Jamie Bestwick. The Board requested that Mr. Bestwick present his proposal regarding the proposed development of an "Action Sports Park" in a municipal park (to be selected). Direction from the Board is requested on how to proceed in a manner that does not involve municipal funding.

C. 2014 Fee Policy c/o Mr. Woodhead

(Attachment # 4) (ACTION)

The Director will review the proposals included in the 2014 Fee Policy, which was distributed at the November meeting. Attachment #4 shows a staff-recommended revision to the proposed policy with respect to the new "Rental Customer Appreciation & Referral Program" at the nature center. Formal Board action of the entire policy is requested.

D. Interim Parks Maintenance Facility c/o Mr. Carpenter

Mr. Carpenter will update the Board on the progress of moving to the Interim Parks Maintenance Facility, as well as presenting a summary of the shared renovation costs by the landlord and the agency. All items should be moved by the end of this month.

E. Regional Park Updates

1. Oak Hall Regional Park - Phase 1

(ACTION)

- Board approval is requested to authorize a payment of \$24,230.52 to West Penn Power Co. to provide 3-phase, 480/277 volt, 55kw service to the park. This approval will also grant an easement to West Penn Power to provide that service. This service is independent of any service for the future public well by the CT Water Authority. The service fee is based on a service contract from the sole-source vendor; the funds were allocated in the project budget. Similar payments were made to West Penn Power for each prior capital project.
- Mr. Wenger & Mr. Pashek will update the Board on the park construction project, which has largely been suspended for the winter. The project remains on-budget and on-schedule. Spring 2014 weather conditions (for construction and turf growth) will determine if the park will be able to fully open in Fall 2014 or Spring 2015.

2. Whitehall Road Regional Park - Phase 1 + Parks Maintenance Facility

- Mr. Pashek will provide an update on the Municipal Land Development process for the park, the proposed Toll Brothers student housing development and the possible schedules for bidding and construction for the park and the Parks Maintenance Facility. It is noted that the funding package for the Parks Maintenance Facility must still be considered by the COG General Forum. Proposals for engineering services are currently being finalized; then the financing discussions will be scheduled.
- Mr. Pashek will report on the options regarding the two requests from Centre Soccer Assn. to:

(Action)

- A. Further widen the two primary soccer fields in the Phase 1 project. If this option is to proceed, the Land Development Plans and the Stormwater Management Plan must be (promptly) revised to reflect that layout prior to the final submission to the Township. The additional consulting fees for those revisions would be approximately \$7,020. Given the Phase 1 Project Budget Ceiling of \$5,546,000 for a 75-acre park, Centre Soccer Assn. has been asked if they are able to provide funding for engineering g that expansion.
- B. Provide a Bid Alternate to install artificial sportsturf, perimeter fencing and lighting on those two fields. While the project will be engineered to allow these improvements at any time in the future, preliminary estimates are as follows:

Protective fencing	\$31,680
Nailer curb	\$96,600
Aggregate base and drainage	\$1,404,000
Synthetic turf surfacing	\$934,000
Lighting for the two larger fields	\$350,000
